

NOVEMBER 2022 | DIESIS ARTICLES SERIES "ACCELERATOR OF SOCIAL ENTERPRISES!" ROMANIA'S FIRST SOCIAL ECONOMY CLUSTER REGISTERED ON THE EUROPEAN CLUSTER PLATFORM

At the end of 2021, **ADV Romania** registered the **Accelerator of Social Enterprises Cluster** in the **European Cluster Platform** - an initiative of the European Commission funded by the EU Competitiveness of Enterprises and SMEs (COSME) programme.

ADV Romania launched the Accelerator of Social Enterprises program in 2019 and became a grant administrator for 42 social enterprises established and developed in Romania. This program became a social economy cluster in 2020.

The establishment of the Accelerator of Social Enterprises Cluster represents for ADV Romania the next stage of coalescence and development of the social economy sector in Romania.

"Together, we can be a **voice** and an **example of the social and economic impact social enterprises have**, learn from each other, develop products and services in the value chain and even develop partnerships for **innovation** and **sustainability**.", said **Angela Achiței**, social entrepreneur and **president of ADV Romania**.

Currently, the cluster comprises **60 members from Romania and the Republic of Moldova**, primarily social enterprises but also authorities and educational institutions. The cumulated employment of cluster members is **319**, and the total turnover is **3.000.000 euros**. Most of the members of this cluster are also founding members of AFIN IFN SA, the first non-bank financial institution with Romanian capital for financing social enterprises.

The Accelerator of Social Enterprises Cluster aims to help social enterprises grow and become more competitive, thus multiplying their positive impact on local communities and the environment. With this in mind, ADV Romania created the first interactive map of social enterprises, a platform that connects social enterprises from Romania, the Republic of Moldova and Ukraine with buyers and companies driven by a strong social commitment.

Among the support services provided by the cluster, we can find:

- advisory services,
- access to public and private funding,
- facilitation of collaboration between members (within the cluster),
- support training services for cluster managers/policy makers,
- upskilling and reskilling expertise,
- staff mobility, access to training, etc.

## Why are these clusters important?

The "clustering" of the social economy is a recent and growing social movement in the European Union.

Social and green innovation clusters are ideal vehicles to align local SMEs, social enterprises, citizens' initiatives, local and regional authorities and research centres to contribute to the digitisation and sustainable transition of the local and community economy.

Social enterprises and industrial clusters have proved valuable in crisis response and recovery, as they have demonstrated concrete actions of solidarity, cooperation, innovation and regeneration. The European dimension is equally visible in the drive of clusters to expand their model and learn from other structures. Clusters deliver prosperity across many sectors, help build resilient local value chains, and serve many stakeholders.

Clusters go far beyond simple networks, implying a more substantial commitment and ownership from all stakeholders and a willingness to share resources and decisionmaking on common aspirations.

The main strength of these clusters is their capacity and know-how for cooperation stemming from the values promoted by the social economy and their ability to experiment and innovate.

Among the priorities most pursued by these clusters are job creation and local economic development. In some cases, the focus is exclusively on developing a regional "social economy ecosystem" by creating an enabling environment of conditions and support. In most cases, this stems from a social ambition - social inclusion, work integration, education, a green and circular economy promotion, etc. The majority of social and innovation clusters are engaged in **interregional and international networks**. ADV Romania is member of <u>RISE - Romanian Network</u> of Insertion Social Enterprises, which is the only member from Romania in ENSIE - European Network for Social Integration Enterprises. In 2022 ADV Romania also joined <u>Diesis Network</u>, one of the widest European Networks specialised in supporting social economy and social enterprise development.
